Officers Reports:

- Pres. Recommends; 1) board consider establishing a 100' buffer for trees in green belt (Country Hollow side bottom of the hill) 2) We need to decide which board member will hold the treasurer seat through the year. (note: Tim is selected for this) 3) Consider replacing the Southridge play set on 184th St Ct E because the reserve study suggests 2018 is the year (note: we should look at it and decide may not need to do this yet) 4) We should update the appeals process document.
 - -- Also for the record since a member asked, it should be noted that Phil Durben has missed 6 board meetings and the annual meeting over the last year.

<u>Management Report:</u> Violation, Collection and others are emailed to board members prior to meetings to save paper costs and to give board a chance to preview. Board members are asked to let us know if they want paper copies.

1) Collections:

- <u>A)</u> Delinquent Assessments Nov 10% (\$335,555.63 (172 of 1,776 homeowners) past due); Dec 9% (\$346,631.83 (164 of 1,776 homeowners) past due); Jan 8% (\$356,034.19 (145 of 1,776 homeowners past due).
 - a. For a short period; because of the aggressiveness of collections, the dollar amounts go up (against the uncollected accounts) but the number of delinquent homeowners continues to steadily decrease as they pay off their balances (sort of working a curve that will go down the other side soon).
- <u>B)</u> Delinquencies (and dollars past due) are working their way down as every year additionally Atty. (Pody McDonald) has collected on many accounts report attached.
